
#### FROM YOUR TREASURER ~ SARAH SULLIVAN, CGFO

As of December 31, 2011, the Association had \$1,017.18 in the bank. The calendar year loss of expenses over income was \$36,800.64. The board approved to write off approximately \$16,000 of unpaid memberships that are more than 2 years old. This was done as of December 31, 2011. There was also a payment to Myrtle Beach Convention Center for the 2010 Fall Conference attrition. This was for \$21,714. These two factors are the main reasons for the loss. I am reviewing the membership accounts

listed in the financial software and will be sending member statements out soon. Please review these statements and contact me if there are any errors.

Thank you to all who have paid their 2012 annual dues. In order to maintain certifications and attend conference and classes at a member rate, members must be in good standing with no amounts outstanding. ## SCHOLARSHIP OPPORTUNITIES COMMITTEE CHAIR ~ DENNIS LOCKE, CGFO

One of the goals we have as a board this year is to promote the educational opportunities given by our association for scholar-ships that are available through GFOA. Currently we have two academic scholarships that we are accepting applications for.

<u>The Willa S. Bellamy Scholarship</u>, in the amount of \$2,000, will be awarded to a college student who attends a public four-year college or university. The scholarship is awarded to a rising sophomore, junior, or senior based on academic achievement and faculty recommendation. All full time students majoring in Finance, Accounting or Business Administration who are SC State residents, attend public colleges and universities and maintain a 3.0 cumulative GPA are eligible to apply.

<u>The Founding Fathers Scholarship</u>, in the amount of \$500, will be awarded to a college student who attends a public two-year college or university. The scholarship is awarded to a technical college or USC two-year college student based on academic achievement and faculty recommendation.

Submission Deadline: Applications must be received on or before April 16, 2012. These scholarships will be awarded at the GFOASC Spring Conference on May 7, 2012.

The association also awards the <u>Katherine Zook Certification Program Scholarship</u> which covers the costs of registration fees and books for the five certification courses. The applicant must be a member (regular or agency) of the GFOASC. Submission Deadline: Applications must be received on or before August 31, 2012. This scholarship will be awarded in September prior to the classes that begin in the Fall. The recipient will be announced at the Fall Conference in October.
