The current late fee is \$15.00 and will increase \$35.00 on May 31, 2019. The new GFOA Certification brochure will be added to the GFOASC website late May or mid-June. Three hundred-eight (308) financial officers have been certified since 1999 and one hundred seventy-five (175) are currently active. The Certification Committee consists of ten (10) members. Angie McInchok presented the certification to the new CGFO’s.
